Our nurses are involved with every client, and they oversee all aspects of care and communication with the families.

Many of our clients live alone and/or their families are not local, or they are also very busy with their own lives, families, and career. Our nursing team is there to help schedule appointments, transport our clients to their appointments, ensure any medications are obtained, and report back to the family all the valuable information so that the client and their families have the peace of mind that a medical professional is coordinating care for their parents or grandparents.

Who we can help and why

Dependable and capable caregivers are invaluable, and there is a shortage of the very best. In order to operate in this environment, and to fully leverage our Nurse Forward approach to home care, we have established minimum levels of care. These minimum levels of care reflect the caregivers desire to obtain fulltime hours with the minimum number of shifts. Without these minimum levels of care, it is difficult to recruit and retain these valuable resources. This then explains how the shortage of caregivers has impacted the home care industry as well as the senior living communities that many of our clients reside in.

Our 8 hours per shift minimum, 6 hours with management approval, or 4-hour shifts that are sequential at select senior living communities, allows us to recruit and retain the very best. This also allows us to offer <u>significantly</u> greater caregiver consistency. **Our home care practice is built to help those with the greatest need.**

Our Approach to Home Care

Memory at Home

Memory at Home is a program that focuses on helping clients and their families who are facing the challenges of dementia, Parkinson's, and other cognitive issues. This help is provided through our team of nurses and Certified Dementia Specialists. These are caregivers who are experts in the care of clients who are facing these challenges. Our Certified Dementia Specialists and nurses have nearly 50 hours of course instruction, testing, and weekly meetings to discuss key learnings and review difficult cases.

Our curriculum for Memory at Home is based on a collaborative effort between Teepa Snow, the industry's leading expert on helping individuals and families with dementia, CareAcademy, and our nursing team.

Our approach allows the nurses the ability to assess and determine the stage of dementia - and then develop a care plan with the appropriate resources, training, and oversight required to best help the client and their family.

Our Caregivers

Our caregivers are our employees — and as such they must pass extensive background and reference checks. We have complete and comprehensive liability and workers compensation insurance.

We hire for Compassion and Likability - those parts of us that are wired in our DNA. We then provide training and education through our nurses, our leadership team, and a pair of excellent third-party training partners - CareAcademy and the Teepa Snow Institute.

Our caregivers become part of your family and strive to make their visit the highlight of your loved one's day.
